By application of my registration I hereby agree to abide by all the terms, rules, regulations and code of conduct. I understand and agree my participation in this League is contingent upon my compliance to adhere to the code of conduct and rules of the League. Any violation of these terms and conditions may result in termination of my participation without recourse or remuneration of any kind. No exceptions.

## Participant's Pledge

- I will maintain good standing in school.
- Abide by officials decision. Show good sportsmanship. Play fair and always show sportsmanship.
- Refrain from using foul language or displays or negative messages.
- I will respect the field and practice facilities. I will protect all League facilities and equipment.
- I will always listen and respect Coaches, Adults, Teammates and Officials.
- I am important. I pledge to look after my own well-being of me and the well-being of those around me.

## Participant's Parent/Guardian Code of Conduct

- I(we) understand that this program is for the children and not the adults.
- I (we) will set an example by demonstrating good sportsmanship and positive support for all the children, coaches, League representatives, Board members, officials and all other persons at a League function. (This includes practices, games and all other events.)
- I(we) will always provide support for the League representatives and coaching staff working with our children to provide an enjoyable experience for all involved.
- I (we) will demand a drug, alcohol, vaping and tobacco free sports environment for our children and agree to refrain from the presence and / or use in or around all League events.
- I (we) will require of myself, our children and guests treat all other participants, coaches, officials and all other persons with respect and sportsmanlike behavior at all times, no matter the situation and I(we) will treat all participants, coaches, officials, League representatives and all other persons with respect and will communicate calmly and cooperatively at all times.
- I (we) will abide by all League rules and regulations. I will leave the venue upon request without argument, question, issue or debate.
- I agree no persons other than players, coaches, medics and League representatives are allowed on the playing field. There shall be no exception to this rule.
- No audio visual image or any kind can be posted, shared, exploited, sold or used without the express written prior permission from the League at any time for any reason.

- I (we) will refrain from coaching our children from the spectators area.
- No foul language, combative interactions, name calling, intimidation, altercations, angry exchanges, negative speech, signs, symbols or messages of any kind by any individual for any reason. No exceptions.
- I will abide by field and practice schedules and requirements. Practices are set at the discretion of my team's Head Coach and consistent attendance is required. Game schedules are at the discretion of the League. I understand regular participation in practice(s) before each game is required. Practice(s) improve the team's overall performance and help prevent injury and accidents. Player(s) unable to attend consistent practices prior to League schedule games may observe but not participate in games directly following extended absentee's from practices. Field and practice rules also prohibit dogs, except licensed and uniformed service animals, no food, drinks other than water and no trash.
- No sales, solicitation or profiting from the League or its parents for any reason.
- Use of the NFL flag brand, logo, image or name at any time for any reason without express written permission.
- I(we) understand that if I violate or am part of any violation of any part of this
  code of conduct, I (we) can be removed and suspended for a period of time from
  participation in the League and/or attending any League event and function.
  Serious violation may and will result in permanent dismissal from participation
  and attendance and no refund applies for violations after the Season's first
  game.
